ITINERARY

April 13, 2024 – U.S.A. / San Jose: Depart from Newark for your flight to San Jose. Arrival to Juan Santamaría International Airport. After process in immigration, you will exit the terminal where you will see a guide holding a placard with your Group name on it. After meeting your guide at the airport, private transfer to your hotel. Overnight and welcome dinner at the hotel. (Breakfast, Dinner)

April 14, 2024 - San Jose: Breakfast at the hotel. Morning is at leisure. Enjoy an afternoon city tour of San Jose. During this journey we will visit the National Theater, also known as "The jewel of San José", a masterpiece in art and architecture built by Costa Ricans and completed in 1897. Then we will visit the Museum of Gold (an archaeological interest site), then the Central Market, place full of the Costa Rican cultural heritage and traditions, where you will be able to browse and buy some local art crafts. We will also visit the Metropolitan Cathedral. As we travel around the city, we will point you out several historically important or main buildings in our city, for example The Costa Rica University, The Old Train Station, The National Liquor Factory, The National Supreme Election Bureau, the Asamblea Legislativa (equivalent to The Congress), The Metallic Building, some parks and various sites of interest. This will be an introduction to our Capital City, and information about our economy, cultural, politics, religion and general current events. Dinner is at a local restaurant, after city touur. (Breakfast, Dinner)

April 15, 2024 - San Jose: Breakfast at the hotel. Private transfer to hospital for a meeting. (Breakfast)

April 16, 2024 – San Jose / Doka Coffee Tour & La Paz Waterfall Gardens / La Fortuna (Arenal): After breakfast at the hotel, depart to the North Zone to La Fortuna de San Carlos, home of the Majestic Arenal Volcano. On route we will visit The Doka Estate to do the Coffee Tour. You will be able to live a sensory experience of coffee, from its different stages to its unique aroma. After lunch, continue to La Fortuna. After check -in dinner is at the hotel.(Breakfast, Lunch, Dinner)

April 17, 2024 – La Fortuna: Breakfast at the hotel. Today day you will enjoy a nature tour in The Caño Negro Wildlife Refuge, that is one of the best sites on the continent for bird watching. In addition to an abundance of birds, Caño Negro is also home to many exciting animals, such as sloth, three types of monkeys, caimans, lizards, bats, and a variety of flora native of the wetlands.
